Ball Camp Pike will no longer run contiguously through this area. A portion of Ball Camp Pike is being removed, so there will be non-contiguous sections of Ball Camp Pike, which does not comply with the Knox County Street Naming Ordinance. The portion of Ball Camp Pike being removed runs from just south of the Byington Solway Rd intersection to the northeast point of parcel 091PA037. This proposal is to rename the portion of Andes Road to Hitching Post Drive since it will connect to Hitching Post Drive to the west (see the red road segment encircled in purple in Exhibit B). 3. Addressing staff coordinated with Knox County Engineering and Public Works to determine appropriate street names for these segments based on the logical extension of connecting streets. 4. The proposed street name changes from Ball Camp Pike and Andes Road to Hitching Post Drive will require three addresses to be assigned. 5.
